PD Management Board's Motions on PD Supplementary Rules Re: WDSF PD FINANCIAL REGULATIONS

WHEREAS the WDSF Presidium has been given the mandate to establish a working group (comprised of an equal number of representatives from the PD and WDSF Presidium) with the task of establishing Supplementary PD Rules (to replace the relevant existing PD rules) in time for the 2014 WDSF General Meeting and PD Meeting,

and **WHEREAS** the PD Supplementary Rules consist of:

- a) WDSF PD Administrative Rules
- b) WDSF PD Financial Regulations
- c) WDSF PD Supplementary Competition Rules,

and **WHEREAS** the prepared draft amendments to the WDSF PD Financial Regulations were reviewed and amended according to the proposed Motion of the WDSF Presidium to Amend Article 17 of the WDSF Statutes by the Chair of the WDSF Legal Commission,

MOVED that the WDSF PD Financial Regulations amendments be adopted as set out below by coloured deleted and amended parts of the text.







FINANCIAL REGULATIONS of the WDSF Professional Division

The WDSF PD charges Fees by the authority of the <u>WDSF Statutes</u> and by the authority of <u>PD</u> Regulations.

The amount of the Fees shall be fixed and paid in Swiss Francs (CHF), <u>except that the</u> WDSF PD <u>Management Board</u> may allow payment of granting and other Fees (except the <u>Delegate Registration</u> Fee) in Euros (EUR) and/or US Dollars (USD) using any fixed exchange rate as determined by the WDSF for the current year.

1. <u>REGISTRATION</u> AND ANNUAL <u>REGISTRATION RENEWAL</u> FEES

1.1. <u>Registration</u> Fees

The Fee for <u>Registration</u> of <u>a new-Delegates</u> under Articles 17 of the WDSF *Statutes and the WDSF <u>PD</u> Administrative Rules* is <u>CHF 700.00</u> and is due within one month from the Member's receipt of Notice of <u>Registration of Delegates</u>.

1.2. Annual Registration Renewal Fees

For Delegates nominated by WDSF Member bodies which are Full MembersCHF700.00For Delegates nominated by WDSF Member bodies which are Provisional MembersCHF400.00

1.3. Due Date for the Registration Renewal Annual Fees

<u>Fees for the Registration Renewal</u> for any year are due on January 1st and are to be paid not later than March 31st of that year.

2. COMPETITION GRANTING FEES

2.1. Jurisdiction

Fees for granting the right to organise international WDSF PD Championships, Cups and other WDSF PD Competitions according to the WDSF PD Competition Rules <u>shall</u> be fixed by the WDSF PD Management <u>Board</u>, presented to the WDSF PD <u>General Meeting</u>, and made available <u>on</u> the WDSF <u>Web Page</u> no later than June 30 each year for the <u>following</u> calendar year.

2.2. Payment terms

All Competition Granting Fees must be paid by the <u>relevant</u> WDSF <u>PD</u> Member <u>body</u> at least one month before the date of the subject competition. Granting Fees may not be set off against any other debt or claim.

3. ORGANIZER'S OBLIGATIONS TO THE PARTICIPANTS AT THE WDSF PD COMPETITIONS

3.1. Obligations to the competitors

Minimum expense reimbursements and benefits to be provided by the organizers to the competitors at WDSF PD competitions will be fixed by the PD Management <u>Board</u>, presented to the WDSF PD <u>General</u> <u>Meeting</u> and made available <u>on</u> the WDSF <u>Web Page</u> no later than June 30 each year for the next calendar year.

3.2. Obligations to the Adjudicatorsand, Chairpersons and Supervisors







<u>Every</u> Organiser <u>shall</u> provide travelling expenses (economy class air fare at weekend tariffs, or first class rail travel, including taxi or own car airport transfers) and expenses for entry visas if applicable. If <u>an</u> <u>official's</u> own car is used, the reimbursement per kilometre shall be comparable to <u>the cost of using</u> public means of transport with the maximum of 0.40 \notin /km. The minimum fees <u>payable</u> to the Adjudicatorsand₂ Chairpersons <u>and Supervisors</u> at PD competitions are the same as determined by the WDSF Financial Regulations.

3.3. Minimum Prize Money at the WDSF PD competitions

<u>The PD</u> Management <u>Board</u> shall fix the minimum Prize Money <u>for</u> WDSF PD Championships, Cups, Super Grand Prix Series and PD Open World ranking Competitions, present it to the WDSF <u>PD General Meeting</u> and make it available <u>on</u> the WDSF <u>Web Page</u> no later than June 30 each year for the next calendar year.

4. FEES FOR WDSF PD ATHLETE'S AND ADJUDICATOR'S LICENSES

4.1. Athlete's Licenses

The WDSF PD Managing Body may set an Annual Fee for a WDSF PD Athlete's License in the amount of no more than CHF 50.00 per competitor. The <u>proposed</u> PD Athlete's License fee for the <u>following</u> calendar year will be presented by the PD Management <u>Board</u> to <u>every</u> WDSF <u>PD General Meeting</u> and made available <u>on the WDSF Web Page</u> no later than June 30 each year for the next calendar year. All athletes wishing to <u>receive a</u> PD Athlete's License <u>must</u> apply for WDSF Athlete's ID cards and pay the costs to the issuer of the ID cards through <u>their governing WDSF Member body</u>. Unregistered athletes may not compete in <u>any</u> PD competition.

4.2. Adjudicator's and Chairperson's Licenses

<u>The</u> WDSF PD <u>Management Board</u> may set an Annual Fee for a WDSF PD Adjudicator's License in the amount of no more than CHF 110.00. Licenses are issued in <u>the</u> electronic form and displayed <u>on the</u> <u>WDSF Web Page</u>. For the new licences issued after August 31st in the calendar year 50% of the annual license fee will be charged. The <u>adopted</u> PD Adjudicator's License fee for the <u>following</u> calendar year will be presented by the PD Management Body to <u>every</u> WDSF <u>PD General Meeting</u> and made available <u>on</u> <u>the WDSF Web Page</u> no later than June 30 each year for the next calendar year.

4.3. Payment terms

Annual Fees for WDSF PD Athlete's and Adjudicator's Licenses are due on January 1st and must be paid by the <u>governing WDSF Member body</u> not later than January 31st of that year.

5. FEES FOR WDSF PD SEMINARS

5.1. Registration Fees for PD licensed adjudicators and athletes at the PD Seminars

Each active PD Licensed Adjudicator or PD registered Chairperson will be allowed to attend PD Seminars at a special fee fixed by the PD Director in the amount not exceeding CHF 50.00 per person and published at the announcement of the Seminar.

5.2. Registration Fees for PD Seminars for other participants

Registration fee for all other participants at the WDSF PD Seminars will be fixed by the PD Director in the amount not exceeding CHF 100.00 per person and published at the announcement of the seminar.

6. PENALTIES







<u>A WDSF Member body which</u> fails, refuses or neglects to pay any fees set out in these Regulations, by the time they are due, shall in addition to such fees pay an additional charge of CHF 100 for each invoice which is paid late, and <u>Delegates appointed by that body</u> shall cease to be in good standing <u>and cease to have a valid vote in any WDSF PD General Meeting or postal ballot without further notice</u> until all such fees and all additional charges are paid in full. <u>The appointment or other registration of other appointed</u> <u>PD Officials may be revoked by the Management Board without further notice</u> after the third reminder sent by e-mail. <u>For clarity, further</u> consequences remain reserved under Article 14 of the WDSF Statutes.

7. EFFECTIVE DATE

This version of the Financial Regulations shall come into force and effect on June 30, 2013 July 1st, 2014.
